One year ago A. A. Moen came here from Tennessee. He is enthusiastic about his prospects. He is a carpenter but will devote most of his time to tracking. He has several acres of potatoes planted and will plant one acre of cantaloupes and a half acre of sweet pepper. From what he has seen of the country he says he is confident that a man can make a success of potatoes and other truck crops if he will use good management in marketing his crops.

#### WHO WAS THIS GUY?

Amund Anthon Moen was born in Norway in 1855 and immigrated with his family to the USA in 1864. As an adult, he lived in Tennessee where his son Joseph was born in 1898 in Elkton (see picture below) & daughter Mary, born farther west in Haywood county in 1900. In 1911 the family moved to Sweeny and was growing potatoes, cantaloupes and sweet peppers. He died in Sweeny in 1914 and is buried in Tennessee. After Amund died, his wife Rosa (1879-1966) married Henry D Martin (1869-1956). They are buried in the Sweeny cemetery along with their daughter Nettie Martin Kilsby.
