

WHEREAS, the return of the said election was made to the County Judge within ten days after the 14th day of April, 1945, the date upon which the said election was held; and

WHEREAS, I, FLOYD ENLOW, County Judge of Brazoria County, Texas, have examined the said return of the said election and have found, and do hereby adjudge and decree, that the election was in all respects conducted in accordance with law; that a majority of the votes was cast in favor of the said incorporation, and that the return of the said election was properly and timely made.
